COMPLAINT FOR ABSOLUTE DIVORCE

- 5. My spouse and I have completed and signed a Parenting Plan, and we believe it is in the best interest of the minor child. I have attached the Parenting Plan to this Complaint.
 - 6. I am not seeking alimony.
 - 7. My spouse and I have no marital property that needs to be decided by the court.
- 8. I am not making any request for use and possession of the family home or any family personal property.
- 9. My spouse and I have pursued separate lives or lived separate and apart, without interruption, since September 25, 2024.

- 10. I have not participated, as a party or witness or in any other capacity, in any other proceeding concerning the custody of or visitation with the child.
- 11. I am not aware of any proceeding that could affect the current proceeding, including proceedings for enforcement and proceedings relating to domestic violence, protective orders, termination of parental rights, and adoptions.
- 12. I am not aware of any person not a party to this proceeding who has physical custody of the child or claims rights of legal custody or physical custody of, or visitation with, the child.
